SUBJECT: SWORN AFFIDAVIT: Formal criminal complaint naming Barack Hussein OBAMA et al aka Barry Soetoro and all alias he is using and OBAMA's CRIMINAL ASSISTANTS et al in commission of the crime of TREASON against the United States of America.

- 1. We are arrived at a point in our Nation's life where Barack Hussein OBAMA and OBAMA's CRIMINAL ASSISTANTS threaten the life of our Nation to the point of death. OBAMA and his CRIMINAL COHORTS installed an unconstitutional, rival and competing government that replaces our United States Constitution.
- 2 Mr. OBAMA's unconstitutional government is thriving and growing. Under Mr. OBAMA the United States Constitution no longer operates. Mr. OBAMA and his OUTLAW PARTNERS enforce only their own form of unconstitutional, treasonous government.
